MDX Hawaii's online access for providers is only available to providers who are contracted as MDX Hawaii Preferred Providers. By completing this form, you are requesting to be a Master Administrator for the provider with the Tax ID Number(s) noted below. A Master Administrator will have the ability to perform the following functions:

- Create or disable a User account (including any billing service)
- Change or update an account
- Change or re-set an account password
- Assign permissions for each User account
- Assign sub-administrators for the Tax ID Number(s) listed below. Sub-administrators are only able to view and edit the accounts they have created. Examples of sub-administrators are other departments within a facility, billing companies, etc.
- View and make changes to any of the accounts listed under the Tax ID Number(s) below.
- Have access to all of the users for the Tax ID Number(s) listed below.
